

**County of Tioga**

**Local Law No. 1 of the Year 1979.**

**A Local Law providing for a Board of Ethics of County of Tioga.**

**Be It Enacted by the Legislature of the County of Tioga as follows:**

- 1. The Board shall consist of five members, with no more than three of such members being registered with the same political party and a majority of such board shall not be officers or employees of the County of Tioga or any municipality wholly or partly located in the County of Tioga.**
- 2. The Tioga County Legislature shall appoint all members of such Board who must be residents of the County of Tioga from two lists of six candidates submitted by the two major parties of the County.**
- 3. The term of office for each member of such Board shall be five years, except for the first four members appointed to such Board whose term of office shall be one, two, three and four years respectively.**
- 4. No person shall be appointed to such Board for more than one full five year term.**
- 5. Each year the Board shall elect their own chairman for a one year term, prior to January 1st of that year.**
- 6. One member of such Board must at all times be an elected or appointed officer of the County of Tioga or a municipality located within the County.**
- 7. The members of said Board shall receive no salary or compensation for their services as such member.**
- 8. The County of Tioga hereby relinquishes its power to remove any member of such Board at its pleasure but reserves the right to remove any member for cause, namely conviction of any felony or misdemeanor violation of the laws of the State of New York or the United States of America, or for conduct unbecoming a member of such Board or for physical or mental incapacity to function as a member of such Board.**

**This Local Law to be effective on the 1st day of September, 1979, and upon filing of the Law pursuant to Section 27 of the Municipal Home Rule Law of the State of New York.**

Such local law was submitted to the people by reason of a (mandatory)(permissive) referendum, and received the affirmative vote of a majority of the qualified electors voting thereon at the (general)(special)(annual) election held on , 19 , in accordance with the applicable provisions of law.

4. (Subject to permissive referendum and final adoption because no valid petition was filed requesting referendum.)

I hereby certify that the local law annexed hereto, designated as local law No. of 19 of the (County)(City)(Town)(Village) of was duly passed by the on , 19 , and was (approved)(not disapproved)(repassed after disapproval) by the on , 19 . Such local law was subject to permissive referendum and no valid petition requesting such referendum was filed as of , 19 , in accordance with the applicable provisions of law.

5. (City local law concerning Charter revision proposed by petition.)

I hereby certify that the local law annexed hereto, designated as local law No. of 19 of the City of having been submitted to referendum pursuant to the provisions of section (36)(37) of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the (special)(general) election held on , 19 , become operative.

\*Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis or, if there be none, the chairman of the county legislative body, the mayor of a city or village, or the supervisor of a town where such officer is vested with the power to approve or veto local laws or ordinances.

6. (County local law concerning adoption of Charter.)

I hereby certify that the local law annexed hereto, designated as local law No. \_\_\_\_\_ of 19 \_\_\_\_\_ of the County of \_\_\_\_\_, State of New York, having been submitted to the electors at the General Election of November \_\_\_\_\_, 19 \_\_\_\_\_, pursuant to subdivisions 5 and 7 of section 33 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.

I further certify that I have compared the preceding local law with the original on file in this office and that the same is a correct transcript therefrom and of the whole of such original local law, and was finally adopted in the manner indicated in paragraph 1, above.
