Local Law No. 3 of the Year 1992.

A Local Law restricting parking on County Property.

Be It Enacted by the Legislature of the County of Tioga as follows:

SECTION 1: TITLE

This Law shall be known as the Local Law restricting parking on County Property.

SECTION 2: DECLARATION OF PURPOSE

In order to provide adequate and safe parking for County employees and all other persons using County facilities, all parking in and on property owned by Tioga County shall be regulated by this Local Law.

SECTION 3: DESIGNATED AREAS

(1) Pursuant to Section 215 of the County Law and Sections 1670 and 1803 of the Vehicle & Traffic Law, parking in all County-owned parking lots shall be restricted on Monday through Friday from the hours of 8:00 A.M. to 6:00 P.M.

(2) The Commissioner of Public Works shall designate each parking lot in accordance with the following designations:

A. Open Parking: This designation shall allow all persons, employees and visitors who have business or other related activity within a County owned facility to park in a County Parking Lot.

B. Visitor Parking: This designation shall allow visitors parking only. Employees shall not be allowed to park in these designated areas.

C. Employee Parking: This designation shall allow employee parking only.

D. Juror Parking: This designation, when in effect, shall allow Juror parking only.

(3) The Commissioner of Public Works shall, in his discretion, be authorized to restrict parking at such additional days and times as he shall deem necessary.

(4) Each lot shall be posted with a sign setting forth the appropriate restrictive classification. The sign shall be further designated by an alphabetical, numerical or color code.

(5) Parking during non restricted hours shall be limited to passenger vehicles only.

SECTION 4: EMPLOYEE PARKING PERMIT

(1) The Commissioner of Public Works shall have the authority to further restrict employee parking lots by Department or other employee classification.

(2) Employees shall be provided with a sticker to be placed on the driver's side window. Only employees with the appropriate sticker shall be permitted to park in the designated lot.

(3) The Commissioner of Public Works shall provide the appropriate departments with applications for permits for the employee parking lots. The Department Head shall determine the distribution of the applications. A copy of the permit shall be maintained by both the Department Head and the Commissioner of Public Works. Once issued, the permit and sticker shall remain in effect, unless the employee shall terminate employment or transfer to another location. A copy of the permit shall also be placed in the employee's personnel file.

SECTION 5: OPEN VISITOR & JUROR PERMITS

(1) Parking in open or visitor parking shall be permitted without permit or sticker designation.

(2) The Juror Parking Lot shall have a gate that shall allow exit only upon payment by token. Jurors shall be provided with a token from the Court which will allow them to exit the Juror Parking Lot.

SECTION 6: VIOLATION

It shall be unlawful for any person, other than those persons authorized, to park in a designated County parking lot.

SECTION 7: PENALTY

(1) Any person who shall fail to comply with the provision of this Local Law shall be guilty of a violation and shall be punishable:

(A) By a maximum fine of twenty-five dollars (\$25.00) for the first offense; fifty dollars (\$50.00) for the second offense within a twelve (12) month period; and one hundred dollars (\$100.00) for the third and each subsequent offense within a twelve (12) month period.

(B) By imprisonment not exceeding thirty (30) days; or

(C) By both such fine and imprisonment.

(2) In addition to the criminal penalties provided herein, the County may commence a civil action/proceeding to enjoin or obtain any available legal or equitable remedy, including the imposition of civil fines equal to those set forth in Section 7(A).

(3) The County shall have the right to pursue civil penalties or other remedies regardless of whether a criminal proceeding has been or is to be commenced.

SECTION 8: REMOVAL OF VEHICLE

(1) The Commissioner of Public Works or any Police Officer shall remove and store any vehicle in a County parking lot:

(A) When parked in a lot or driveway during a snowstorm, flood, fire or other public emergency; or

(B) When unattended and constituting an obstruction to traffic; or

(C) When found abandoned.

(2) Any owner or operator of a vehicle so removed, shall be responsible for the payment of reasonable charges for the removal and storage of said vehicle.

SECTION 9: ENFORCEMENT OF APPEARANCE TICKETS

Police Officers, Peace Officers and such persons as shall be so designated by the Commissioner of Public Works are hereby authorized to enforce this Local Law and to issue appearance tickets for violation of this Local Law.

SECTION 10: SEVERABILITY

If any clause, sentence, paragraph, section or part of this title shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof involved in the controversy in which such judgment shall have been rendered.

SECTION 11: EFFECTIVE DATE

This Local Law shall be effective immediately upon filing with the Secretary of State.

4. (Subject to permissive referendum and final adoption because no valid petition was filed requesting referendum.)

I hereby certify that the local law annexed hereto, designated as local law No. of 19 of the (County)(City)(Town)(Village) of was duly passed by the on , 19 , and was (approved)(not disapproved)(repassed after disapproval) by the on , 19 . Such local law was subject to permissive referendum and no valid petition requesting such referendum was filed as of , 19 , in accordance with the applicable provisions of law.

5. (City local law concerning Charter revision proposed by petition.)

I hereby certify that the local law annexed hereto, designated as local law No. of 19 of the City of having been submitted to referendum pursuant to the provisions of section (36)(37) of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the (special)(general) election held on , 19 , become operative.

*Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis or, if there be none, the chairman of the county legislative body, the mayor of a city or village, or the supervisor of a town where such officer is vested with the power to approve or veto local laws or ordinances.

6. (County local law concerning adoption of Charter.)

I hereby certify that the local law annexed hereto, designated as local law No. _____ of 19 _____ of the County of _____, State of New York, having been submitted to the electors at the General Election of November _____, 19 _____, pursuant to subdivisions 5 and 7 of section 33 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.
