- **Question 7**: Based on your RFP there is a project based format and a managed security based format that we feel could be of value. Would we be able to present two different options to the county for review?
- **Answer 7:** Yes
- **Question 8**: Appendix B looks like a cost table, however would we be able to deliver the SOW in our format, as well?
- **Answer 8:** Yes as long as it is in addition to Appendix B.
- **Question 9:** Our Controller spoke with our president about your request for the *list of cancelled contracts* for the past 3yrs and our president confirmed that we cannot provide Tioga County this information due to Non-Disclosure Agreements we have signed. Will the exclusion of this information restrict us from further pursuit of this RFP?
- **Answer 9:** If such is the case, the vendor must at least disclose the total number of contracts that were cancelled in the last 3 years, how many of those were subject to non-disclosure agreements, and disclose the requested information for those not subject to a non-disclosure agreement. If the non-disclosure agreement prohibits disclosure of even this minimum level of disclosure, the vendor must so state, and Tioga County will take this into consideration in its decision making.
- **Question 10:**Is Tioga County intending to purchase these *services* via State Contract? We need to know only for logistics purposes on our end.
- Answer 10:No.
- **Question 11:** As it relates to Section 3.6 B. Evaluation and Selection Criteria: What are the weighted percentages associated with each of the 7 categories listed to be evaluated?
