**NOTICE OF VACANCY**  
**PUBLIC HEALTH NURSE**

**Date of Issue: 06/19/2017.** An incumbent of this position is responsible for the performance of public health nursing activities including specific tasks as mandated by New York State Public Health Law. Work is performed under the general supervision of the Supervising Public Health Nurse or in his/her absence the Deputy Director of Public Health. Does related work as required.

The title of Public Health Nurse is **Competitive**. Applicants must meet the minimum qualifications and comply with civil service examination requirements. An examination announcement is currently posted. The test consists of an evaluation of a candidate's training and experience. Pending a criminal background check\*, an appointment may be made to this position. Permanent appointment will be dependent upon participation in the examination AND being reachable from the resulting eligible list.

**Status:** Permanent, upon satisfactory completion of a probationary period  
**Work Hours:** Full time, days; 35-hour work week  
**Salary:** \$51,172 (2017 – CSEA sg XV); benefit package available including: health, dental and vision insurance, paid leave time, NYS Retirement System, Deferred Compensation Plan  
**Location:** Tioga County Public Health Department

**Minimum Qualifications:**

Licensure and current registration to practice as a Registered Professional Nurse in New York State and a Bachelor's degree in nursing from a regionally accredited or New York State registered college or university. Copy of college diploma is required at time of application.

**Special Requirement:**

Appointees must satisfactorily complete all applicable training courses approved by the State Health Department within designated time frames.

Possession of a valid New York State driver's license appropriate to the vehicles operated or otherwise demonstrate their ability to meet the transportation needs of the job.

Must be available in the event of a public health emergency.
