- **D. ED&P Update** L. Tinney provided the following update:
  - → Project Freehold Meeting needs to be scheduled.
  - → Town of Nichols Public Hearing needs to be scheduled for site plan review.
  - → REAP ED&P providing assistance with restructuring their purpose/mission.
  - → Ag Economic Development Specialist –Process of interviewing candidates with one additional interview scheduled 3/8/18.
  - → Amish Farmers ED&P assisted both families with STREDC low-interest loan for purchase of equipment and real estate.
  - → Gateway Project Lease expected to be signed for Tourism Office to take occupancy.
  - → Village of Owego ED&P assisting with NY Main Street application for portion of North Avenue.
  - → Restore NY ED&P assisting the Village of Owego and Village of Waverly.

- → Job Fair ED&P participated in today's job fair at the Owego Treadway with approximately 110 employers and 500 job seekers in attendance.
- PILOT Updates B. Myers 6.
  - A. 2018 Town, County, and Fire Bills All invoices have been paid.
  - B. Spencer-Tioga Solar, LLC (f/k/a SUN 8) B. Myers/J. Meagher Final numbers were not received until 2/13/18 and Cost Benefit Analysis was updated and all information was sent out on 2/14/18. B. Myers reported the Spencer-Van Etten School Board presentation was cancelled due to the weather, however, has been rescheduled for 3/8/18. Presentation made to the County Legislature on 2/22/18. Both the County Legislature and the Town of Spencer had questions and answers were provided. Public Hearing was held on 2/28/18 in the Town of Spencer. To date, B. Myers reported he has not received formal opposition or approval from the three taxing jurisdictions: Town of Spencer, Tioga County Legislature, Spencer-Van Etten School District. B. Myers will follow-up with all three entities.

B. Myers reported the PILOT payment is a lump sum of \$600,000 with no yearly increase. Of this amount, \$30,000 issued to the County.

    - a. Income to Date B. Myers reported the income from 2017 is approximately \$15,000 less than 2016.
- В. Loan Program -
  - 1. Committee Report (R. Kelsey, A. Gowan, K. Dougherty, D. Barton, S. Thomas)
    - a. Wakeup Waffles B. Myers reported Wakeup Waffles is still interested in loan financing, however, is pursuing grant funding first. Also, company is exploring possible partnership opportunities.
    - b. Liberty Research Met with Liberty Research in February 2018 to re-visit last year's loan request for upgrades to on-site water system. Waiting for company to provide additional requested information.



- c. What's In Store/Kathy's Cakes The Loan Committee met earlier today to review the façade loan request for Katherine and James Hankey for roof replacement and new signage installation at 187 Main Street, Owego, NY (former Angel's Diner) for a total project cost of \$11,851.32. The façade loan request is for \$10,000 at 0% interest for five years for a monthly payment of \$166.67. The Loan Committee recommended approval for this façade loan with the following terms/conditions:
  - $\rightarrow$  \$10,000 loan at 0% fixed interest for five (5) years (\$166.67/month)
  - → Kathy and James Hankey shall provide unconditional personal
  - → Loan funds will be used to reimburse up to \$10,000 towards total project cost of \$11,851.32 for roof replacement/signage at 187 Main Street, Owego, NY.
  - → Key person life Insurance on both Katherine and James Hankey for at least the amount of the outstanding debt and assigned to the Tioga County Industrial Development Agency shall be provided. A provision can be made for the insurance to decline as the loan is repaid, retaining an insured amount on the policy equal to the amount of the declining loan balance.
  - → Collateral includes 2<sup>nd</sup> security interest on the real property located at 187 Main Street, Owego, NY. The private lender will be in 1<sup>st</sup> position for \$40,000 loan.
  - $\rightarrow$  All applicable local, state and federal requirements to apply.
