

# **STRATEGY**

## 2019 HIGHLIGHTS

- Projects funded by the 2017 Downtown
   Revitalization Initiative were announced by New
   York State in August. Contracts are expected in
   early 2020.
- Voigt & Schweitzer New York Galvanizing, LLC broke ground in 2019. A \$15.5 million dollar investment, the site is expected to be fully operational beginning in early 2020.
- All 15 Tioga County municipalities completed and adopted the Tioga County Multi-Jurisdictional Multi-Hazard Mitigation Plan, which was also approved by FEMA and NYS DHSES.
- Tioga County Regional Economic Area
   Partnership LDC (REAP) was awarded a USDA
   RBDG grant to study code enforcement potential
   shared services in the County, which started in
   September 2019 and will be complete by the end
   of June 2020.
- New visitors to the Tioga County Tourism website increased by 103%.
- The Village of Waverly Planning Board is working with Thoma Development Consultants to update the Village's 1981 Comprehensive Plan.
- The Land Bank completed demolition of nine unsafe, blighted properties.

### LAND BANK


The Tioga County Property Development Corporation, a New York State land bank, was established as a nonprofit 501(c)(3) organization in January 2017. The following has been completed in 2019:

- Structures demolished in the Village of Waverly at 429 Chemung Street, 108 Park Street, 112 Park Street, 452 Cayuta Avenue, 127 Providence Street, 530 E. Chemung Street, and 457 Fulton Street.
- Structures demolished in the Village of Owego at 115-117 Chestnut Street, 39-41 Temple Street, and 117 Liberty Street.
- 35 Lincoln Street, Waverly readied for rehabilitation and sale.
- 207 Howard Street, Waverly readied for rehabilitation and sale.

## **TOURISM**

Tioga County Tourism (TCT) embarked on a series of new projects, planning, and programming this year. As part of the 2019 Tourism Strategic Plan, TCT invested in paid digital marketing campaigns with the goal of increasing traffic to www.experiencetioga.com. As a direct result, website traffic doubled and social media engagement increased dramatically. Also of note:

- The Tioga GeoTour brought in geocachers from all across the United States and Canada. With 451 Favorites, it's a popular tour.
- Thanks, in part, to participation on the Haunted History Trail, Fainting Goat Island Inn was voted the #2 Haunted Hotel in the U.S. in a USA Today 10 Best contest.
- Since opening, the Visitor Center has hosted approximately 200 visitors per month.
- Over 3,000 emails were collected as part of the Vacation Contest Digital Campaign.



## **COMMUNITY DEVELOPMENT**

- Implemented the Tioga County Foundations Coalition public web portal: https://www.tiogacountyny.com/tioga-county-foundations-portal/
- Worked to facilitate the implementation of the Tioga County Housing and Community Investment Initiative and laid the groundwork for the formation of the Tioga Neighborhood Revitalization Coalition.
- Attended municipal meetings each month and created a database of priority projects.
- Began work to update REAP's Strategic Plan and continued to build upon strong partnerships with area municipalities, as well as agencies such as Tioga Opportunities, Southern Tier 8, Cornell Cooperative Extension, etc.
- Provided technical assistance for the Village of Waverly Waverly Glen Park Improvements Project.

### AGRICULTURAL DEVELOPMENT

- 8 Year District Review- Tioga County consists of 3 agricultural districts as defined by NYS Ag and Markets. On their 8 year anniversary dates, districts undergo a review process where land can be added or removed from the district. In 2019, ED&P began preparations for 2 of the districts, whose 8 year review periods will begin in early 2020.
- Annual Inclusion Enrollment- Each year, the department holds its annual agricultural district
  enrollment period in January. During this time, any agricultural property owner may request
  inclusion of viable agricultural land not already included in a certified NYS Ag district. In 2019,
  Tioga County added 74.33 acres of land into existing Ag districts.
- Food Hub: Exploring an Innovative Approach-Tioga County farmers are always looking for new
  opportunities to market their goods. In 2019, ED&P began exploring how a food hub model
  would fit in the county, and what it would mean for county farmers. With potential partners
  identified, 2019 marked a great start to expanding markets for local producers.
- Ag Tires Recycling Program- Partnering with Tioga County's sustainability manager and the Soil
  and Water Conservation District, ED&P began work on a recycling program for agricultural
  tires. Using a grant that was awarded through Soil and Water in 2019, the three departments
  will work together to create a way for Tioga County farmers to rid their farms of old, unwanted
  tires in a cost effective and environmentally friendly way in 2020.

# PLANNING + ZONING 239M REFERRALS

The Tioga County Planning Board received 17 referrals from various municipalities throughout the County for recommendation on development projects. Especially interesting projects include the High End Multi Processing CBD oil extraction facility in the Town of Barton and four Community Distributed Generation solar projects, one each from the Town of Candor, Town of Tioga, Town of Nichols, and Town of Owego.

The Village of Spencer established a Land Use Commission with the intention of exploring the feasibility of regulating land use by zoning within the Village.



## WORKFORCE DEVELOPMENT PIPELINE STRATEGY

Phase I of the Tioga County Workforce Development Pipeline Strategy was completed in May of 2019. TEAM Tioga, in partnership with REAP, submitted an application to the USDA and was awarded funds to conduct Phase II of the study. Phase II of the plan is currently in progress.

It is anticipated that Phase II will be completed by June of 2020 with the following deliverables:

- A strategic action plan that will identify priorities and actions needed to help employers attract and develop talent and workforce supply for today and for the future
- Strategies that will connect local school districts and higher learning institutions, with employers, to create a highly qualified and skilled workforce pipeline
- A labor strategy vision for Tioga County

### INDUSTRIAL DEVELOPMENT AGENCY

- \$693,700 Assessed Value was added to taxable roll section.
- The New York State Comptroller Audit was successfully completed in 2019.
- The Industrial Development Agency (IDA) contributed to the 4th Wave Study on battery technology.
- The IDA continued to support the Tioga County Housing and Community Investment Initiative.
- Two new PILOT Agreements were approved in 2019: Voigt & Schweitzer New York Galvanizing, LLC and Home Leasing/Owego Gardens II.
- Voigt & Schweitzer New York Galvanizing, LLC broke ground in 2019. Located in the Town of Owego, this \$15.5 million dollar investment is projected to create approximately 60 new jobs. The site is expected to be fully operational beginning in early 2020.
- Additionally, with support from the IDA, Voigt & Schweitzer New York Galvanizing was awarded \$18,000 through the NYSEG Economic Development Natural Gas Infrastructure Investment Program.

## **2020 CENSUS**

The 2020 Census is starting soon. Residents in Tioga County will be receiving an invitation in mid-March to complete the 2020 Census Form online or by phone. The Tioga County Complete Count Committee (CCC) started work to make residents aware of the 2020 Census last April. A customized logo was created and promotional materials were developed with the help of a graphic designer. The 2020 Census was promoted at the Tioga County Fair, the Older Adult Health Fair, the Chamber of Commerce's Non-Profit Mixer, and Lights on the River. Census Bureau 2020 Census chip clips and lip balm, as well as Tioga County CCC logo canvas grocery bags were all distributed to local food banks. CCC promotional efforts will intensify in 2020 via various methods, at least until the end of May. To assist financially with this, the CCC is awaiting a Request for Applications from the NYS Complete Count Committee to secure nearly \$73,000 for additional promotional products, advertising, and events.
