

## LOCAL LAW INDEX

### ATTENDANCE AT CONVENTIONS, CONFERENCES, AND SCHOOLS

Local Law No. 2 of the year 1974 – A Local Law delegating to the Chairman of the Tioga County Legislature the authority to authorize officers and employees to attend conventions, conferences, and schools at County expense.
