- A. Wunder Lease- W. Wunder has a land lease with the IDA. The lease was written in the 90's and has not been modified since. W. Wunder has not paid his lease payment for 2025 due to the IDA removing the sheds on the property. W. Wunder requests that he does not have to pay the lease payment for 3-4 years due to the sheds being removed. The IDA is the owner of the land and sheds. The board agreed that W. Wunder would need to pay the lease payment if he was using the property. J. Meagher will update the lease agreement.
- B. Audit RFPs- The Landbank has agreed to move forward with Bonodio's proposal for audit services and the LDC will decide tomorrow at their board meeting. The proposals were scored by B. Woodburn, the land bank administrator and the director of Tourism. The two proposals received were similar in cost.

The business applicant is located in Tioga County and is looking to lease a trailer, which would be purchased from a local company in Nichols. The applicant does not have the upfront funds for the total cost of the trailer, around \$12,000. The IDA has not had any applicants for the equipment lease program. The applicant is seeking assistance purchasing the equipment. With the current Equipment Lease Guidelines, the applicant must purchase the equipment and then the IDA will request reimbursement from USDA to pay for the equipment. The IDA would own the equipment until the lease is paid in full. C. Yelverton modified the Equipment Lease guidelines to include language "TCIDA may consider requests from the business/owner to authorize other purchasing arrangements" to accommodate more applicants. The application will be reviewed by the loan committee and then presented to the board for final approval.



About the TCIDA

Established in 1971, the mission of the Tioga County Industrial Development Agency is to promote, develop, encourage and assist in acquiring, constructing, maintaining, equipping and furnishing certain types of projects and facilities, to advance the job opportunities, health, general prosperity, economic welfare and recreation opportunities of the citizens of Tioga County.

The TCIDA is overseen by a sevenmember Board of Directors that are appointed by the Tioga County Legislature. TCIDA and Tioga County have a Memorandum of Understanding agreement in place for staffing and office space. The Board meets on a monthly basis, with ED&P staff providing oversight of day-to-day operations

TCIDA's Work in 2025



In October 2025, TCIDA received a PILOT application from Lockheed Martin Corporation located in the Town of Owego. The project includes renovating and modernizing 70,000 square feet of building 080 of the Owego Campus. The newly renovated facility will be used for helicopter integration and supporting flight operations. New machinery and equipment will be purchased and installed as a part of the project as well. The estimated \$51 million project will bring approximately 100 new full-time equivalent manufacturing jobs to the Owego site, along with construction jobs during construction of the project. TCIDA worked with Lockheed Martin Corporation throughout the application process, completed the Cost-Benefit Analysis, and closed on the PILOT in December so that the project could begin before the end of the year. The project is expected to be completed by the end of 2027, with areas within the project space ready for use mid-2026.



TCIDA closed on Suneast Valley Solar PILOT in October of 2025. This approximately \$47 million project includes the installation of ground-mounted utility-scale energy generation system on leased property on Montrose Turnpike in the Town of Owego. The project will be able to generate 20 MWac of power and will interconnect to the NYSEG Owego 34.5 kV station.

TCIDA's Work in 2025

In 2025, all remaining projects in the TCIDA multi-site program made significant progress, with only 2 projects remaining to be completed in early 2026. The anticipated program completion date is June 2026.

37-41 LAKE STREET, VILLAGE OF OWEGO DRI PROJECT

This project includes exterior improvements to all sides of the building, as well as apartment buildout on the second and third floors. In 2025, the exterior work was completed. The apartments will be completed in 2026.





62-64 NORTH AVE, VILLAGE OF OWEGO DRI PROJECT

Completed in 2025, this project included rehabilitation to the facade of the building at 62-64 North Ave, Owego. A new storefront was completed, along with renovation of the ceiling of the first floor commercial space.





43-45 LAKE STREET, VILLAGE OF OWEGO DRI PROJECT

The DRI project at 43-45 Lake Street included repairs to the exterior entrance way ceilings, building a platform along the Lake Street side of the building, and repairing the old tiled "sidewalks" with brushed concrete.







TCIDA Equipment Lease Program

Tioga County Industrial Development Agency (TCIDA) was rewarded \$99,000.00 in funds from the USDA Office of Rural Development through its Rural Business Development Grant (RBDG) program for funding to support the development of the TCIDA Equipment Lease Program. The Equipment Lease program was established to address a critical need within the community by providing low interest lease opportunities for equipment for businesses located in Tioga County. Leasing mitigates the burden of hefty upfront costs associated with purchasing equipment outright. This financial flexibility enables businesses to allocate capital more strategically, fostering growth and innovation. The IDA will continue to offer the program in 2026.



TCIDA's Work in 2025



RICHFORD RAILROAD STUDY

The TCIDA contracted with Larson Design Group to conduct a preliminary engineering and design report for the replacement of a railroad bridge located in the Town of Richford. The completed report included preliminary engineering plans, environmental, geotechnical studies, and cost estimates The report also identified that the bridge would need to be fully replaced due to the condition and inadequate size.



RAYMOND HADLEY WATER STUDY

The TCIDA contracted with Larson Design Group to evaluate the construction of water distribution and service infrastructure to provide water from the T. of Van Etten to a business located in the neighboring V. of Spencer in Tioga County, NY. This evaluation addressed the feasibility of several alternatives for water distribution construction. The findings were presented to the Town of VanEtten and Raymond Hadley and funding sources were explored for potential future water expansion.



LOUNSBERRY INDUSTRIAL AREA STUDY

The TCIDA was awarded \$90,000 in funds from the USDA Rural Business Development Grant program for the TCIDA Lounsberry Industrial Sites Engineering Plan. TCIDA contracted with Hunt Engineers to conduct a preliminary engineering report for two detached properties owned by the TCIDA. The report included wetland delineation, geotechnical reports, Environmental Site Assessments, surveys, and topographic surveys which will assist the IDA in applying for and obtaining a shovel ready designation under Track A and funds to support capital projects that would make the sites shovel ready under Track C of the FAST NY program.



SOUTHERN TIER CLEANTECH STRATEGY

New York and its Southern Tier region are undergoing a major economic transformation driven by a shift toward clean energy manufacturing and clean energy generation. A partnership of eight southern Tier IDA's retained Newmark to identify ways to leverage local assets to build out a clean energy and cleantech ecosystem. Newmark provided the Southern Tier Economic Development Organizations (EDO's) with their study findings. TCIDA met with representatives of Newmark regarding the findings and discussed options for future development in Tioga County.
