APPROVAL OF MINUTES

Legislator Brown made the motion, seconded by Legislator Roberts to approve the March 9, 2023 Legislative Support minutes, as written. Motion carried.

FINANCIAL

2023 YTD Budget Report: The 2023 Legislative Office YTD Budget Report is included in today's committee agenda packet that was emailed to all Legislators prior to this meeting. To date, budget utilization is 22.5% with nothing significant of note.

County Auditor Accounts Payable Report: As the County Auditor for Accounts Payable, Ms. Haskell reported she will be giving a monthly report to the Legislators regarding the number of invoices processed each month. In March, Ms. Haskell reported 865 Accounts Payable invoices in the amount of \$2,800,346.28 and 150 Purchase Card transactions in the amount of \$45,277.11 were audited and processed. Legislator Standinger inquired as to whether any issues were noted. Ms. Haskell reported inaccurate invoices are rejected and workflow back to the Department for correction. Ms. Haskell reported Departments are notified by email when an invoice is rejected, and it is the Department's responsibility to correct and re-release for review/approval.

Local Law No. 1 of 2023: Notification received on March 16, 2023 from the New York State Department of State that Local Law No. 1 of 2023 – Establish Salaries of Office of County Clerk and Sheriff for the four-year term commencing January 1, 2024 and ending December 31, 2027 was filed on February 21, 2023. This local law takes effect on January 1, 2024.

Board of Ethics Vacancies: The Legislature currently has two vacancies to fill on the Board of Ethics. Legislator Standinger reported he may have an interested candidate.

Cybersecurity Awareness Training: The first mandatory quarterly cybersecurity training is on USB Security. Legislators that have not yet completed this training should do so as soon as possible. This training is through the KnowBe4 platform, and everyone should have received a training link via email.

Annual Policy Review/Attestation: The annual policy review and attestation form was due on March 31, 2023.

Annual Financial Disclosure Forms: The Financial Disclosure forms must be completed and submitted to the County Attorney's Office no later than May 15, 2023.

NEW BUSINESS

Sales Tax Extender Bill: Ms. Haskell reported she is working with Assemblyman Friend's office to obtain the Bill numbers for both the Assembly and Senate in order to proceed with the Sales Tax Extender Home Rule Request resolution. Ms. Haskell reported that all counties were advised to inform their State delegation to proceed with a 2-year sales tax extender Bill that will expire November 30, 2025 even though we currently have a 3-year sales tax extender in place. Our current sales tax extender expires November 30, 2023.

The Assemblyman's Office is waiting for the State budget to be passed. Depending on the timing, Ms. Haskell reported she may be able to present a late-file resolution at the

RESOLUTION NO. -23 HOME RULE REQUEST IN SUPPORT OF S05804-A/A05775A: EXTENDING THE CURRENT AND IMPOSING ADDITIONAL SALES AND COMPENSATING USE TAXES BY THE COUNTY OF TIOGA

WHEREAS: The continuation of previously authorized additional sources of revenue is required to enable counties, such as Tioga County to meet the ever-increasing costs of delivering essential governmental services to their citizens without undue reliance on local property taxes; and

WHEREAS: The New York State Senate and Assembly are in agreement that individual counties should request their State delegation to introduce two-year home rule sales tax extenders expiring as of November 30, 2025; and

WHEREAS: State Legislative authority is needed to extend the current sales and compensating use taxes for the County of Tioga at the same level and upon the same terms and conditions as now currently exist; therefore be it

RESOLVED: That the Tioga County Legislature hereby requests enactment of Senate Bill No. S05804-A and Assembly Bill No. A05775A entitled "An Act to Amend the Tax Law in relation to extending the authorization of the County of Tioga to impose an additional one percent of sales and compensating use taxes through November 30, 2025.
