- The moving operations continue.
- Buildings and Grounds and Highway collaborated in cutting many dead Ash trees on the HHS walking trail to increase safety.
- In recognition of October as Domestic Violence month, Building and Grounds installed purple up-lights. (November will be switching to green for Veterans)
- Mr. Hammond reported on the Highway Department.
 - Milling completed on Goodrich Road and Sulphur Springs Road.
 - Paving is complete on Goodrich Road.
 - Patch paving was completed on Sabin Road and Crumtown Road.
 - Shouldering for Nichols and Candor roads as well as West Creek Road and Sulphur Springs Roads was completed.
 - Ditching on Straits Corners Road was completed.
 - Driveway culvert replacements have been installed on Straits Corners Road.
 - Excavator work done for Richford as part of shared services.
 - Stream cleaning on Halsey Valley Road and West River Road weir completed.
 - The mowing operations continue.
 - There has been a speed limit change on Sabin Road. The town of Spencer requested the change, and it was forwarded to the state and was approved.
 - We received one new truck and expect another delivery next week.
 - Tioga County Highway Department is participating in the Truck or Treat event in the park on Halloween.
- Mr. Hammond reported on the Buildings and Grounds Capital Projects.
 - The finalized roof contracts for the Court Annex/Clerks and the Courthouse are being reviewed.
 - The Court Annex boiler is assembled and being installed by Martin Plumbing.
 - The control work for the Court Annex and Probation rooftop units is the last part of the construction project remaining to be completed. Buildings and Grounds have had only minor issues this far with either rooftop unit.
 - The Ronald E. Dougherty County Office Building North Wing HVAC upgrade project is anticipated to start Tuesday, October 14th.
 - The Public Safety Building control work project scope is still being built and nearing review stage.
 - The Public Safety Building VFD cooling fan has been ordered and is awaiting arrival.

 - Brown Road Bridge over East Branch Owego Creek is in the preliminary design phase.



BEVERAGE PURCHASE GUIDELINES

WHEREAS: The Tioga County Department of Public Works will be conducting (3) three successive training sessions on Friday, November 7th, 2025, which will effectively last all day; and

WHEREAS: County Policy – Section III; Subsection H. Purchase of Food, Beverages, and Supplies limits expenses to \$150 per event for a permissible required all day training for County employees; and

WHEREAS: These training(s) will occur prior to adoption of this resolution, the Public Works Committee Chair has authorized the Commissioner of Public Works to exceed the Food and Beverage Guidelines in advance, and

WHEREAS: Public Works will be providing lunch with the expenses anticipated to exceed the \$150 per event limit; and

WHEREAS: Requests to exceed event limits must be made by resolution and require the approval of the County Legislature; therefore be it
