## ABSTRACT OF PROPOSAL NUMBER TWO, A PROPOSITION

### LOCAL LAW 2022 - #2

THE TOWN OF TIOGA AMENDING TOWN LAW SECTION 24, TO INCREASE THE TERM OF OFFICE FROM TWO TO FOUR YEARS AS HIGHWAY SUPERINTENDENT, SUBJECT TO MANDATORY REFERENDUM ON NOVEMBER 8, 2022

The Town of Tioga Board adopted on February 8<sup>th</sup>, 2022, Local Law 2022-#2, "Amendment of Town Law Section 24, to increase the Town Highway Superintendent term from two years to four years.

Local Law 2022-#2 would change the position of the Town of Tioga Highway Superintendent from a two year term to a four year term by the Town of Tioga Town Board.

If approved and adopted in the Town of Tioga, this Local Law to change the Town Highway Superintendent from a two year term to a four year term, would become effective immediately upon filing in the Office of the Secretary of State.

## TEXT OF PROPOSAL NUMBER TWO, A PROPOSITION

### LOCAL LAW 2022 - #2

#### LOCAL LAW INCREASING TERM LIMITS

A local law increasing the Term of Office of the Highway Superintendent from (2) two to (4) four years.

Be it enacted by The Town Board of the Town of Tioga as follows:

**Section 1: Statutory Authority:** This local law adopted pursuant to the provisions of the Municipal Home Rule Law of the state of New York.

**Section 2: Increase Term of Office:** The term of office of the elected Highway Superintendent shall be (4) four years. Such (4) four year term shall commence as of the first day of January 2024 and shall apply to the person elected to such office at the biennial Town election to held on November 8<sup>th</sup>, 2022 and to those elected thereafter, provided a proposition submitted pursuant to Section three below is approved.

**Section 3: Mandatory Referendum:** This local law is adopted subject to a mandatory referendum and shall be submitted for approval of the qualified voters of the Town of Tioga at the biennial Town election, and the increased term of office shall not take effect unless proposition is approved by the majority of the qualified voters voting thereon:

Shall Local Law 2022-#2, entitled a Local Law increasing the Term of Office of the Highway Superintendent from (2) two to (4) four years be approved?

**Section 4: Supersession:** This local law shall supersede Town Law, Section 24 relating to the term of office for the Highway Superintendent of the Town of Tioga.

**Section 5: Effective Date:** The local law shall become effective immediately upon filing in the Office of the Secretary of State after approval by the qualified voters.
