**Local Law No. 1 of 2023:** Ms. Haskell reported Local Law No. 1 of 2023 – Establish Salaries of Office of County Clerk and Sheriff for the four-year term commencing January 1, 2024 and ending December 31, 2027 was adopted at the Second Regular Legislature Meeting on February 14, 2023 and sent to the Secretary of State, State Records and Law Bureau, and County Clerk on February 16, 2023 for filing.

**Board of Ethics Vacancies:** Ms. Haskell reported the Legislature has two vacancies to fill on the Board of Ethics. Email was sent to the Legislators on February 13, 2023 regarding notification of the second vacancy.

#### **NEW BUSINESS**

- Amend Employee Handbook Section III. Financial Rules, Subsection E. Grants Procedure Ms. Haskell reported the Exec Team reviewed and revised the original policy and, in addition to several other small changes, the primary revision of this policy is that all grants written for the County or by the County on behalf of another municipality or entity will now require a resolution. This allows for transparency, so the Legislature is aware of the potential grant funding coming into the County, as the Legislators hold a fiduciary responsibility. In addition, this policy also allows for retroactive resolutions providing the timing of the grant announcement and grant submission deadline is a short turnaround and does not fall within the timeframe of the Legislature meetings. The Budget Officer and Chief Accountant also reviewed the proposed policy revisions and were in agreement.
- Urging Governor Hochul to Reconsider Ban of Gas Stoves and Other New Fossil
  Fuel Heating Equipment This resolution is to request the Governor's
  reconsideration of her proposal of banning gas stoves and other new fossil fuel
  heating equipment, as this proposal places an undue burden on our homeowners
  and businesses to convert their existing equipment at a time when the cost of
  living has significantly increased.
